Family-owned winery founded in 1925 by Mr. Antonio Candela García. At the beginning, we only produced wine from our own grapes. In the 40's, we started to buy little amounts of other grapes, marketing 250,000 litres a year, with the name of "Antonio Candela Poveda" (founder's son).

Over the years, we have widened our facilities, depending on production and marketing needs, and modernized production techniques: from hand-made processes until automation; as well as our storing containers, from wood until satinless steel with French or American oak.

Since 1996, we turned into a limited company, named "Bodegas Antonio Candela e Hijos, S.L.", directed and managed by 2nd and 3rd family generation. We have two modern production and preservation wineries, and we are planning to build a third one, located at the vineyards, focused on varieties and quality selection and production, for later bottling and marketing.
